# Administrators' Reports

**Director of Pupil Services** – Mr. Hanson reported that he recently attended the joint Special Education Directors, Title 1, DACS, and Principals meeting at CESA 8 with Mr. Trevillian where the main focus was providing guidance and direction for the Joint Federal Notification Package on ESSA/IDEA. He also reported that the Early Childhood Developmental Screening day for children ages 3-5 is scheduled for Tuesday, March 19<sup>th</sup>. Other items Mr. Hanson reported on include:

- 1. Family Literacy Night is scheduled for Thursday, March 28th
- 2. Collaborating with Wisconsin Deaf Hard of Hearing Outreach program on an upcoming site visit and evaluation
- 3. Continuing to analyze special education caseloads and comparing to other districts in CESA 8

**<u>Principal</u>** – Mr. Trevillian reported that Career Day was February 1, everything went well and there was multiple speakers from a variety of career field.
