Scholarship Application

To: All area students of Bay De Noc Community College (West Campus) enrolled in the spring, summer, or fall semesters of the 2018-2019 academic year.

The Dickinson County Office of Veterans Affairs and Dickinson County Area Veterans Alliance are offering a scholarship opportunity to any current fulltime student of Bay De Noc Community College (West Campus) or area student who intends to attend Bay De Noc Community College (West Campus) in the 2019-2020 year. Our goal is to encourage education, reflection, and patriotism, through thoughtful remembrance, for all who sacrificed their lives in service to this great country.

As love of this country has no age requirement, no place of residence, nor academic standard, neither does this scholarship. Applicants may be enrolled full time in any curriculum - vocational or academic. They need only be current fulltime students in good standing at Bay De Noc College (West Campus) or to have been accepted for the 2019-2020 academic year with the honest intent to attend. Gaining the scholarship and then attending another institution will result in forfeiture and/or repayment.

The amount of the scholarship is \$400. A winner and runner-up will be chosen. The winner will be required to read/recite his/her own **original** essay during the Dickinson County Memorial Day remembrance on 27 May, 2019 at the county courthouse. If the winner is unable to read his/her essay, the runner-up will be asked and will receive the award upon compliance.

Scholarship Application Requirements:

Submitted work must be between 1,000 and 1,500 words, double-spaced.

Accepted spelling and conventional usage are expected.

Topic: "How We Are Remembering Our WWI Veterans on the 100th Anniversary of That War"

Deadline is May 2, 2019

All applicants must be available to read their essay at the Memorial Day ceremony at the Dickinson County Courthouse on May 27, 2019. The scholarship will be presented at that time.

Essay must be typed, double-spaced, 1,000 – 1,500 words.
